- 2. Policy GBA Equal Employment Opportunity. Mr. Law moved to adopt the policy with changes. Ms. Bush seconded. All in favor.
- 3. Policy GBEC Drug Free Work Place Change is adding the Cross Reference IHAMB. Mr. Law moved to adopt the policy with said changes. Ms. Bush seconded. All in favor.
- 4. Policy GCF Professional Staff Hiring. The only change added is gender identity. Ms. Bush moved to adopt the policy with said changes. Mr. Law seconded. All in favor.
- 5. Policy IHAMB Teaching about Alcohol, Tobacco, and Drugs. More education was added to the policy. New last paragraph. Ms. Bush moved to adopt the policy with changes, Mr. Law seconded. All in favor.

- 6. Policy IJ Instructional Materials. Changes include gender identity; regulations; CMR. Mr. Law moved to adopt the policy with said changes. Ms. Bush seconded. All in favor.
- 7. Policy JB Equal Educational Opportunities. References at bottom have changed. Big change is gender identity. Ms. Bush moved to adopt the policy with said changes, Mr. Law seconded. All in favor.
- 8. Policy JFBB School Choice. Change: gender identity; added BESE Regulations reference. Mr. Law moved to adopt the policy with changes. Ms. Bush seconded. All in favor
- 9. Policy JICH Alcohol, Tobacco, and Drug use by Students Prohibited. Changes are: defines use, possession, the purchase or sale. Spells out what products are. "Any controlled substance" Must be posted on website. Ms. Bush moved to adopt to policy with changes. Mr. Law seconded. All in favor
- 10Policy JKAA Physical Restraint of Students. Changes include: superintendent procedures; necessary & unnecessary retraint; additional reporting; covers someone getting hurt. Mr. Law moved to adopt the policy with changes. Ms. Bush seconded. All in favor.
- 11. Policy JLCD Administering Medicines to Students. Changes to allow the use of Narcan without parent or guardians permission .Mr. Law moved to adopt the policy with changes. Ms. Bush seconded. All in favor.

There was discussion of the good Samaritan Law. There was discussion of Narcan.

Ms. Bush moved to adjourn. Mr. Law seconded. All in favor. Meeting adjourned at 3:22pm
