1. **Call to Order:** Bonnie Silvers, Chair, called meeting #1546 to order at 6:05 p.m. Ms. Silvers asked for a moment of silence for the shootings in Santa Fe.

3. Student Representative Report

Marya Makuc and Sarah Beckwith reported on upcoming activities.

4. **Public Comment**

Mr. Jeff Blaugrund, resident of Alford, introduced himself to the school committee. He informed the committee that he and his wife have enrolled their daughter in EK at the South Egremont School, and very excited about the opening of the school.

Mr. Blaugrund and his wife endorse the opening of the South Egremont School. Right now, they are zoned for Undermountain Elementary as their school of residence and this would mean their 4-year-old daughter would be on a bus for an hour. South Egremont is the more convenient choice.

They feel the school is a benefit to Egremont and the school district. Mr. Blaugrund also mentioned some concerns, i.e. that the South Egremont school had not been advertised enough and that marketing has not been proactive or clear on the opening of the South Egremont School.
